BSSD Registration Instructions for 2019/20 Season:

You will need the forms in this package as well as to sign up for volunteer duties.

- 1. Print the registration package that pertains to you from the website.
- 2. Complete the Class Recommendation For Next Season that was emailed to you. Print and bring to registration.
- 3. Go to www.beaumont.ab.ca to view class schedules. These are posted on the website starting Monday June 10, 2019 at 12:00 am.
- 4. Locate the classes that apply to your child. Please note what the teacher has written on the Teachers Recommendation Sheet(s). If they have indicated Level A for example for a Ballet Class, your dancer needs to take the corresponding Exam class.) i.e. for Grade 2A ballet there will be a Grade 2A Exam Class offered). If they have indicated a Level B Class then your dancer can take the corresponding Ballet Technique Class if they choose. (i.e. for Grade 2B ballet there will be a Grade 2 Ballet Technique Class offered.) If you have any questions, prior to registration, please attend the Question & Answer session on Monday, June 10 from 7:00 to 9:00 pm in the BSSD Homework Room.
- 5. Do Not complete Section A through I. This will be completed by a BSSD Executive Member at the time of Registration.
- 6. Complete the top part of the registration form. Ensure all demographic information is complete. If no information has changed from last season, check the box that indicates NO CHANGES and we will use the information on file from last year.
- 7. Complete Section J: Read the refund policy. Sign and date.

Credit card payment will be taken on registration dates this year only. VISA, MASTERCARD, American Express and Discovery accepted. Note: there is a \$40 flat fee for all credit card payments accepted.

Dec 1, 2019 NOTE: Only available to those who have over \$500.00 in fees. 10 month payment plan: Divided Line I total by 10.

- 10. Complete the Liability Waiver and Consent to Use Information Form in the registration package. Please ensure you do this as we will be unable to accept your registration without these documents. Many people did not complete this step last year and had to step aside. BSSD will not be providing these forms this year. DO NOT FORGET TO BRING THEM WITH YOU.
- 11. Volunteer & Fundraising Duties. You are responsible for signing up for your volunteer/fundraising duties on the website at www.beaumontdance.ab.ca. Please find the Volunteer icon on the home page and click it to go to the sign up site. Duties will be filled on a first come first serve basis as usual. You will need to either select 2 duties or 1 duty depending on what you choose. ALL duties must be completed in full to avoid your cheque being cashed. If you select 2 duties and only complete 1 or if you cancel your duty with 7 days or less notice to the Volunteer Coordinator, your cheque will be cashed. If you wish to pay out your Volunteer/Fundraising Duty, please date your cheque for July 1, 2019 in the amount of \$250.00 and it will be deposited in July. Otherwise you will need to write a post dated cheque for \$500.00 for January 1, 2020.

Note:

- 1. Any outstanding fees from 2019/2020 season or prior seasons MUST be paid in full by cash or money order payable to BSSD before your registration for the 2019/2020 will be accepted. This includes ALL performing fees as well.
- 2. All cheques written MUST have the dancer(s) first and last name printed on the front in the lower left corner where it says memo.
- 3. If you have a family of 2 or more dancer(s), the volunteer/fundraising duty requirement is by Family.

Registering for a New Discipline/Class or a New Family Member

- 1. Adding a new class let the registrar know at the time of registration.
- 2. Adding a new family member complete the Returning Member Form fill in all demographic information, complete the waiver form, advise the Registrar at the time of registration.



Fee Schedule - 2019/20

The payments are to be divided into equal payments for 4 or 10 months once all fees have been added in or paid in full. Cheques are deposited around the 1st and the 15th of the month.

Picture Fee	\$20.00 per class with costume in year end shows
Fundraising & Volunteer	\$500.00 post dated cheque excluding Adult Classes, Creative Movement, Intro to Dance and Movement & Mobility. If paying out this fee at time of registration \$250.00. Note: if you only do half of your volunteer duty or cancel with 7 days or less notice, your \$500.00 cheque will be deposited.

The Society establishes its budget based on registration fees and offering refunds past the deadline jeopardized the successful operation of the Society for the remaining dancers. You are required to postdate a cheque for Volunteer/Fundraising duties. These will be cashed if ALL of your duties are not fulfilled (i.e. if you only do 1 of 2 duties or a part of your full duty or cancel with 7 days or less notice) or destroyed when your duties are complete.
